Duties and Responsibilities of the VSU Risk Manager, Assistant Risk Manager and Deputy Risk Managers

VSU Risk Manager

- 1. Plan and coordinate the conduct of assessments in the University to define and analyze possible risks (financial, legal, security, health, and others) the university may encounter.
- 2. In coordination with the Deputy Risk Managers, review and evaluate the gravity of each risk by considering its consequences.
- 3. Assist the President in creating contingency plans to manage crises and help implement solutions and plans.
- 4. Partner with key stakeholders to develop and implement standards, processes, programs, and best practices related to risk management.
- 5. Prepare reports and present recommendations to appropriate bodies.
- 6. Do other tasks related to risk management.

II. Assistant Risk Manager

- 1. Assist the Risk Manager in performing all its duties and responsibilities.
- Coordinate with the Deputy Risk Managers in the planning and the conduct of assessments to define and analyze possible risks (financial, legal, security, health, and others) the university may encounter.
- 3. Assist the Risk Manager in the consolidation of reports submitted by the Deputy Risk Managers to the University Risk Manager for submission to the appropriate bodies.

III. Deputy Risk Manager

1. Plan and coordinate the conduct of assessments in their respective assigned offices in coordination with the University Risk Manager to define and analyze possible risks (financial, legal, security, health, and others) the university may encounter.



- 2. Review and evaluate the gravity of each risk by considering its consequences in their assigned offices.
- 3. In their assigned offices, identify potential risk exposures, recommend solutions, implement approved programs, promote loss prevention, and update and monitor compliance of government statutory and regulatory provisions.
- 4. Develop risk management controls and systems and design processes to eliminate or mitigate potential risks in their respective offices.
- 5. Prepare reports and present recommendations to the University Risk Manager.
- 6. Do other tasks related to risk management in their assigned offices.
