**BAC Resolution Declaring Grit Laboratory Furnitures & Equipment Corp., Krypton International Resources Sales & Services, and Yana Chemodities as the Bidders with the Lowest Calculated and Responsive Bid (LCRB), Recommending to the VSU President the Award of Contracts to the said Bidders the Amounts of Eighty-Nine Thousand Two Hundred Pesos (PhP 89,200.00), Two Hundred Sixty Thousand Pesos (PhP 260,000.00), and Three Hundred One Thousand Five Hundred Pesos (PhP 301,500.00), respectively, for the Supply and Delivery of Laboratory Equipment for VSU Villaba (VSU-V-GOODS-21-56)**

**WHEREAS**, a Purchase Request (PR) for the procurement of various laboratory equipment from VSU Villaba were submitted to the Office of the Head for Procurement;

**WHEREAS**, said PR was charged against General Fund, certified for funds availability, and with a total approved budget for the contract (ABC) of One Million Two Hundred Thirty-Eight Thousand Pesos (PhP 1,238,000.00);

**WHEREAS**, the BAC Secretariat scheduled for bidding the said PR with project title "Supply and Delivery of Laboratory Equipment for VSU Villaba (VSU-V-GOODS-21-56)";

**WHEREAS**, the VSU posted an Invitation to Bid (Annex A - ITB) for the aforementioned project in the PhilGEPS, VSU website, and in the VSU Procurement Bulletin Board for 7 calendar days;

**WHEREAS**, a pre-bidding conference was held on 15 November 2021 and attended by the BAC Members, BAC Secretariat, Members of the TWG, End-users, Observers, and Prospective Bidders (Annex B - Minutes of the pre-bidding conference);

**WHEREAS**, in response to the said postings, seven bidders namely, (1) **PRO MAINTTECH CONSULTANCY, INC.**, (2) **LABTRADERS, INC.**, (3) **GRIMIT LABORATORY FURNITURES AND EQUIPMENT CORP.**, (4) **KRYPTON INTERNATIONAL RESOURCES SALES & SERVICES INC.**, (5) **NOVEAULAB CORP.**, (6) **YANA CHEMODITIES**, and (7) **KRYPTON VENTURES INC.**, purchased the bidding documents for five thousand (5,000.00) and submitted their respective bid proposals within the set deadline and receipt of bids on 29 November 2021 at 8:30 AM;

**WHEREAS**, on the same day as the submission and opening of bids, the BAC opened the submitted bids of the said bidders;

**WHEREAS**, the BAC conducted Preliminary Evaluation of the submitted bids and the bidders "passed" (Annex C – BAC Resolution No. 176, Series of 2021);
