

## MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is made and entered into by and between:

**LOCAL GOVERNMENT UNIT OF ALBUERA - OFFICE OF THE MUNICIPAL AGRICULTURE**, a government agency under the Office of the Municipal Mayor and validly existing under the law of the Republic of the Philippines, with registered office address at Poblacion, Albueria, Leyte represented by **Hon. Mayor SIXTO B. DELA VICTORIA**, hereinafter referred to as the "**OMA**".

and

**VISAYAS STATE UNIVERSITY (VSU)**, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700, and converted into a university by virtue of RA 9158 and 9437, with principal office at Visca, Baybay City, Leyte 6521-A, Philippines, represented by the OIC President, **Dr. DANIEL LESLIE S. TAN**, duly authorized by the corporation thru a Board Resolution attached hereto as "Annex A", and hereafter referred to as the "**VSU**";

### WITNESSETH:

WHEREAS **LOCAL GOVERNMENT UNIT OF ALBUERA - OFFICE OF THE MUNICIPAL AGRICULTURE** is a government agency under the Office of the Municipal Mayor, headed by the Municipal Agriculturist **Engr. JEROME P. JUNCO**, responsible for the dissemination of improved farm technologies and approaches in agriculture program and project implementation to increase agricultural productivity and entrepreneurship for the improvement of life of the farmers and fisherfolks.

WHEREAS **VISAYAS STATE UNIVERSITY** a center of excellence in Agriculture in the Visayas is mandated to promote agricultural development and growth and provide the support services necessary to make agriculture and agri-based enterprises productive and profitable to the local government units and its constituents through extension services.

NOW, THEREFORE, for and in consideration of the foregoing premises and mutual covenants agreements and stipulations hereinafter set forth, both parties hereby agree jointly to be partners in any field crops' related extension activities such as trainings and establishment of government-managed techno-demo farms (learning site) and the terms and conditions hereinafter set forth, the parties agree as they have agreed as follows:

#### **LSU ALBUERA - OMA shall:**

1. Provide funds and other logistic support in the establishment and operation of the techno-demo site.
2. Allocate an area for the establishment of the learning site.
3. Designate a techno-demo supervisor to manage and supervise the learning site.
4. Provide farm machineries and equipment in the development of the learning site.
5. Secure the learning site premises against stray animals and thieves
6. Conduct the training during government working days; excluding holidays.
7. Organize and facilitate the training activity.
8. Identify and select the training participants.
9. Ensure the participation of the trainee during the entire duration of the course.
10. Provide the training venue, DLP projector and sound system during the training.
11. Provide the training materials such as writing supplies and others deemed necessary during the training.
12. Provide a copy of the attendance sheet and training program to VSU.
