My research on the "Colonial Urban Planning: The Retreat and Return Cycle of Coastal Dwellers in the Philippines" will be passed on to Prof. Maria Aurora Teresita W. Tabada to incorporate into her project on Coastal Cities at Risk in the Philippines. In the meantime, I will continue overseeing the MAGPANGUAPA extension project until my last day of employment, which will be turned over to my replacement.

Terms and Conditions

Any candidature undertaken previously towards the graduate research degree will be deducted from the scholarship. There may be a delay of up to four weeks in receiving your first scholarship payment after enrolment and you should ensure you have sufficient personal funds to cover this period. The first scholarship payment will include back pay to your scholarship commencement date.

Notes

The LTGRS scholarship is valued at AUD\$34,000.00 per annum for 2024* (pro-rata) and is paid on a fortnightly basis into an Australia bank account. A full fortnightly payment is valued at approximately AUD\$1,303.00. Stipends are awarded for a maximum of three years and six months for a doctoral research degree, or 22 months for a Master by research degree. The LTGRS includes limited paid allowances – please refer to **Schedule A of the Terms and Conditions** for details. Deferrals of scholarships will be considered until 30 June 2024.

Course Notes

The joint PhD includes a tailored program of progress monitoring to fulfil the requirements of both institutions. All candidates will write and submit a thesis for defence by oral examination. On successful completion of the program requirements, you will be awarded a PhD jointly by both institutions.

You will be expected to submit your thesis nine months before your candidature expires – this will be your expected work submission date and will be confirmed after you enrol. You will be able to apply to extend your expected work submission date up until the maximum completion date in keeping with University's graduate research progress and candidature policies.

It is a mandatory requirement that all international student visa holders are required to have an active visa length OSHC from the date of their arrival in Australia until the date their visa expires. The listed OSHC duration is based on you arriving in Australia up to one month before course commencement until your visa expires. If you wish to arrive in Australia for more than a month before your course commencement date, your OSHC policy will need to be extended to include this period. In such an instance, please contact us who can arrange an updated offer letter with extended OSHC duration and new OSHC rate. The length of stay for Postgraduate Research students is generally 8 months longer than the course. This additional time allows students to remain in Australia during the marking of their thesis.
