## Dear Dr. Tulin:

- 6. Submit midyear research progress reports every 1<sup>st</sup> week of July of every year *(Attachment 2)*.
- 7. Submit annual research progress reports every 1<sup>st</sup> week of January of the succeeding year *(Attachment 3)*.
- 8. Present the research highlights or papers during the Research In-house Review and Evaluation (*Attachment 4*).
- 9. Present a paper in the regional/national R&D Symposia/fora (as scheduled by Consortium/National agency concerned with prescribed standard format).
- 10. Submit terminal report three (3) months after completion of research project (Attachment 5).
- 11. Publish articles of significant research findings in indexed/peer reviewed journals; and
- 12. Perform other duties related to the study.

In case of any changes in the title, methodology, project site, and/or budget the approval should first be sought from the University President upon recommendation by the concerned College Dean or Center Director and the Vice-President for Research and Extension.
