CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered by and between:

The VISAYAS STATE UNIVERISTY (VSU), an institution of higher learning established under Pres. Decree No. 470 as amended by Pres. Decree No. 700 and converted into a state university by virtue of R.A. 9158 and 9437, with principal office at Baybay City, Leyte, duly represented by the OIC, President, DR. DANIEL LESLIE S. TAN, hereinafter referred to as the FIRST PARTY;

-and-

Mr. JOVANI CASPI SALVADOR, of legal age, Filipino, a resident of Poblacion, Bajada, Cataingan, Masbate and presently employed with the M/V Ferry 1 of Lapu-Lapu Shipping, Inc. Cebu, hereinafter referred to as the **SECOND PARTY**;

WITNESSETH:

THAT the FIRST PARTY hereby hires the services of the SECOND PARTY, as part-time Liaison Officer of the University who shall take charge of the VSU pouch/bag/goods for transmittal to and from Cebu City;

THAT the SECOND PARTY who is the current purser of M/V Ferry 1 of Lapu-Lapu Shipping Lines shall keep the aforementioned pouch/bag/goods under his custody and shall be responsible for its safety within the premises of the boat until the same will be claimed by a VSU authorized representative;

THAT for and in consideration of the foregoing services, the FIRST PARTY binds himself to pay the SECOND PARTY the amount of ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) per month upon certification of services rendered by the Office of the Head for Procurement:

That the aforementioned job shall take effect on September 01, 2023 until December 31, 2023;

That in the event the SECOND PARTY will be separated from employment from Lapu-Lapu Shipping, Inc., this contract is automatically considered cancelled.
