- 5. Present a paper in the regional/national R&D Symposia/fora (as scheduled by Consortium/National agency concerned with prescribed standard format);
- 6. Submit terminal report three (3) months after completion of the research project (Attachment 5);
- 7. Publish articles of significant research findings in indexed/peer-reviewed journals.

For any changes in the title, methodology, project site, and/or budget, approval should first be sought from the University President upon recommendation by the concerned College Dean, Center Director, Director for Research, and the Vice President for Research, Extension and Innovation.

This appointment supersedes the appointment issued to Dr. Eliza D. Espinosa who is currently on Sabbatical Leave effective November 3, 2023, until October 31, 2024.
