 - d. Submit annual research progress reports every 1st week of January of the succeeding year (Attachment 3);
 - e. Present the research highlights of papers during the research In-house Review and Evaluation (Attachment 4);
 - f. Present a paper in the regional/ national R&D Symposia/ for a (as schedule by Consortium / National agency concerned with prescribed standard format);
 - g. Submit terminal report three (3) months after completion of research project (Attachment 5); and
 - Publish articles of significant research findings in indexed/ peer reviewed journal;
- Maintain frequent communication to offer encouragement to project staff, and nurture collaboration;

- 7. Perform other duties related to the project.
