The National Economic and Development Authority (NEDA) Regional Office VIII (NRO VIII) has engaged the services of Visayas State University (VSU) for the conduct of two (2) Impact Evaluation Projects namely: (1) Impact Evaluation of the Agrarian Reform Infrastructure Support Project – Phase III (ARISP-III) in Eastern Visayas and (2) Impact Evaluation of the Agri-Pinoy Livestock Program (A-PLP) in Samar Island. An Agency-to-Agency Procurement conforming to Section 53.5 of the implementing rules and regulations (IRR) of Republic Act (R. A.) 9184, this engagement is supported by a Memorandum of Agreement (MOA) with Terms of Reference (TOR) executed by both institutions. The project implementation commenced on 01 April 2018 and was completed on 15 May 2020.
