### **GRADUATE TEACHING ASSISTANTSHIP AGREEMENT**

#### **KNOW ALL MEN BY THESE PRESENTS:**

This Agreement made and entered into by and between:

The Visayas State University (VSU), formerly the Leyte State University (LSU), an institution of higher learning, converted to a University through Republic Act No. 9437, with principal office at Visca Baybay City, Leyte duly represented by the University President, **Dr. Edgardo E. Tulin** with principal office at Visca, Baybay City, Leyte herein after referred to as the GRANTOR.

KEN N. FLORENTINO of legal age, Filipino, single with residence and postal address at Ormoc City, Leyte here in after referred to as the GRANTEE;

## WITNESSETH:

WHEREAS, the Visayas State University has to promote staff development through financial Assistance for graduate work in major fields of specialization;

WHEREAS, the GRANTEE has fully and satisfactorily met all the requirements as to qualification, standards and criteria set for Graduate Teaching Assistantship grant;

NOW, THEREFORE, for and in consideration of the mutual stipulations and conditions herein after contained, the parties do hereby agree as follows:

- 1. Subject to the terms and conditions stated below, the University hereby awards to the Grantee, and the latter hereby accepts a Graduate Teaching Assistantship (GTA) grant charged to Special Trust Fund effective Summer 2021-2022 and to terminate after Second Semester 2022-2023 subject to renewal upon recommendation of the Scholarship/ Fellowship Awards Committee and compliance with the pertinent provision in the "Guidelines on Graduate Assistantship Program" and for the completion of the course, Master of Science in Tropical Ecology to be pursued by the Grantee pursuant to and by virtue of this award, unless otherwise terminated earlier in accordance with this covenant. In case of an approved renewal or extension of her Graduate Teaching Assistantship beyond the period specified in this Agreement, there shall be no more necessity for another instrument to be drawn.
