- 5. Present the research highlights or papers during the Research In-house Review and Evaluation *(Attachment 4)*;
- 6. Present a paper in the regional/national R&D Symposia/fora (as scheduled by the Consortium/National agency concerned with the prescribed standard format);
- 7. Submit terminal report three (3) months after completion of the extension project (Attachment 5);
- 8. Publish articles of significant research findings in indexed/peer-reviewed journals.

For any changes in the title, methodology, project site, and/or budget, approval should first be sought from the University President upon recommendation by the concerned College Dean, Center Director, Director for Research, and the Vice President for Research, Extension and Innovation.
