

MEMORANDUM OF AGREEMENT

KNOWN ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT is entered into by and between the following:

VISAYAS STATE UNIVERSITY (VSU), an institution of higher learning established under P.D. no. 470 as amended by P.D. 700, and converted into a state university by virtue of R.A. 9158 and 9437, with principal office at Visca, Baybay City, Leyte, represented by DR, EDGARDO R. TULIN, University President, hereinafter referred to as FIRST PARTY

-and-

The **ENGINEERS NETWORK TECHNICAL TRAINING INSTITUTE**, a private learning consultancy services provider with principal address at 129 Bansalangin Street, Barangay Veterans Village, Project 7, Quezon City, represented by **ENGR. KATRINA CAMILLE MENDOZA**, hereinafter referred to as the **SECOND PARTY**,

Witnesseth that: --

WHEREAS, the **FIRST PARTY**, an accredited institution of learning, seeks to provide its students with the necessary exposure and training in actual worksites to prepare them for employment upon graduation;

WHEREAS, the SECOND PARTY will organize a virtual technical training program composed of eight (8 sessions) in line with the modules indicated in your OJT guidelines for civil engineering students.

WHEREAS, this Memorandum of Agreement (MOA) will serve as an instrument for collaborative efforts between the FIRST PARTY and the SECOND PARTY to further develop life and career skills of students, enhance technical knowledge and skills as well as enrich their skills in communication and human relations;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties bind themselves to the following terms and conditions:

CONFIDENTIALITY: All training modules provided are proprietary of ENTTI. Any duplication, reproduction, or transmission in any form without any written permission is strictly prohibited.-

Obligations of the FIRST PARTY

- 1. The FIRST PARTY shall provide the SECOND PARTY with the list of the names of all of the fort seven (47) participating attendees one (1) week prior to the first session.
- 2. The FIRST PARTY shall be responsible for the attendance of their participants.
- The FIRST PARTY shall abide the Terms and Conditions stated on the Proposal/Invitation that the FIRST PARTY have sent earlier. *See attachments from the previous email for reference.

4. The FIRST PARTY shall abide with these Payment Terms: 30% down payment, settled one (1) week before first session (September 10, 2021). 50% balance, settled on the scheduled date of first session (September 16, 2021). 20% balance, settled full amount, scheduled date of fourth session (September 24, 2021).

Obligations of the SECOND PARTY

- The SECOND PARTY shall provide the schedule with the corresponding topics to the FIRST PARTY
- 2. The SECOND PARTY shall send all outputs used in digital format (presentation materials and certificates).
- The SECOND PARTY shall issue official receipt will be issued once payment is settled in full amount.
- 4. The SECOND PARTY shall send the Registration Form of each session upon down payment
- The SECOND PARTY shall give a ten percent (10%) discount to all civil engineering students AND faculty members, redeemable for all succeeding 2021 ENTTI trainings.
- 6. The SECOND PARTY shall not be liable for the absences made by the attendee.
- 7. The SECOND PARTY shall conduct the training via ZOOM.
- 8. The SECOND PARTY shall send the links via email.

This **AGREEMENT** shall take effect immediately upon signing hereof and shall continue thereafter, provided however that provisions if thus agreement may be amended by written consent by both parties herein and provided further that the SECOND PARTY or the FIRST PARTY reserves the right to withdraw its participation in the agreement upon written notice.




