Dear Dr. Tulin,

I'm writing to inform your good office concerning the result of my qualifying exam for a Ph.D. in Extension Education at the University of the Philippines, Los Baños. The said exam was conducted last Mach 2022 since it was deferred various times due to late approval of my Guidance Advisory Committee and natural misfortunes, which hindered my exam. Graduate students can only apply for the Qualifying Exam in the College of Public Affairs (CPAf) after the approval of the Nomination of Guidance Advisory Committee and to be applied after finishing at least 12 units of the academic courses.

In my case, under CPAf, the qualifying exam is not just about chatting about what courses/subjects I already acquired, what I learned from those subjects, and my possible dissertation topics to be piloted. Still, as I expected, it was a sort of a mini-comprehensive examination since I had already finished three semesters. Furthermore, with all the trials that I've confronted over the last three semesters and now that I cannot continue with my Ph.D. in UPLB, I did not lose any hope that I cannot fulfill my dream of finishing my degree. I believe that all the knowledge that I gained during my previous semesters in UPLB will advance me in building a solid foundation in continuing and chasing the dream of finishing my Ph.D. I feel more defied and eager to pursue my degree in other reputable universities.
