This Contract of Services entered into and executed by and among:

JOSETTE T. BIYO**, hereinafter referred to as "SEI";

<u>EDGARDO E. TULIN</u>, with office address at <u>Visayas State University</u>, <u>Visca, Baybay City</u>, <u>Leyte</u>, hereinafter referred to as "HOST INSTITUTION";

and

WARREN L. OBEDA, of legal age, Filipino and with permanent address at Brgy. Villahermosa, Pilar, Cebu hereinafter referred to as "CIP Graduate Fellow".

-WITNESSETH-

WHEREAS, the **SEI** provides opportunities to its scholar-graduates to work with the DOST System, with government agencies engaged in research and development (R&D), with State Universities and Colleges focused on science and technology programs, and with scientists/researchers implementing DOST funded R&D projects under the "**DOST Graduate Scholars Career Incentive Program**;"

WHEREAS, the Host Scientist/Research Supervisor of the **Host Institution** is willing and able to train DOST-SEI scholar-graduates under the above project;

WHEREAS, the CIP Graduate Fellow has signified his/her intention to participate in the aforementioned CIP for DOST scholar-graduates, to which the SEI and Host Institution have accepted;

WHEREAS, the CIP Graduate Fellow, a DOST-SEI scholar-graduate, whose education, training and experience as indicated in his/her personal data sheet hereto attached as Annex A and made an integral part hereof, is ready, willing, and able to work under the aforementioned Project.

NOW, THEREFORE, in consideration of the above cited premises and their mutual covenants hereinafter set forth, the parties have agreed as follows:

I. DOST- SEI Responsibilities:

- a. Provide funds for the wage/s of the CIP Graduate Fellow, whose designation under the Project is MS Graduate Fellow, based on the existing rate and to be disbursed on a bi-monthly basis;
- b. Monitor and evaluate the CIP Graduate Fellow's performance in the course of his/her training;
- c. Collaborate with the host institution in the implementation of CIP;
- d. Approve the CIP Graduate Fellow's continuation/renewal of contract of service subject to the availability of funds, the request made by the host institution, and his/her work performance;
- e. Maintain personal and employment records of the CIP Graduate Fellow; and
- Undertake activities supportive of the professional growth and development of the CIP Graduate Fellow.
