## Dear Dr Tan,

This is to recommend the appointment of ARTURO E. - 4. Participate in data collection and assist in making reports and carrying out project presentations;
  - a. Participate in the conduct of field research, data collection and analysis;
  - Submit quarterly research progress reports to the OVPREI-RPO (Attachment 1);
  - c. Submit midyear research progress reports every 1<sup>st</sup> week of July of every year (Attachment 2);
  - d. Submit annual research progress reports every 1<sup>st</sup> week of January of the succeeding year (Attachment 3);
  - e. Present the research highlights of papers during the research In-house Review and Evaluation (Attachment 4);
  - f. Present a paper in the regional/ national R&D Symposia/ for a (as schedule by Consortium / National agency concerned with prescribed standard format);
  - g. Submit terminal report three (3) months after completion of research project (Attachment 5); and
  - h. Publish articles of significant research findings in indexed/ peer reviewed journal;
