MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is made and entered into by and between:

VISAYAS STATE UNIVERSITY (VSU), an institution of higher learning established under Pres. Decree No. 470 as amended by Pres. Decree No. 700, and converted into a university by virtue of RA 9158 and 9437, with principal office at Visca, Baybay City, Leyte 6521-A, Philippines, represented by the University President, DR. EDGARDO E. TULIN, hereafter referred to as the "Higher Education Institute / HEI";

RURAL BANK OF HINDANG (LEYTE), INC., (Rural Bank) with principal office at J.P. Rizal St., Hindang, Leyte, represented in this act by REYNALDO A. DAYOLA, President and CEO hereinafter referred to as the "Rural Bank of Hindang (Leyte), Inc.".

WITNESSETH:

WHEREAS, an appropriate authority from Commission of Higher Education (CHED) has been issued in favor of HEI authorizing the same to offer program(s) with practicum or internship units;

WHEREAS, HEI has no pending complaint or administrative / criminal / civil action filed against it either before CHED, other government agencies / entities or any court of competent jurisdiction;

WHEREAS, HEI proposes that its students be allowed to undergo practicum / internship at the RURAL BANK OF HINDANG (LEYTE), INC., whereby proposal was accepted / approved by the latter, subject to terms and conditions provided for in this Memorandum of Agreement;

WHEREAS, the RURAL BANK OF HINDANG (LEYTE), INC., hereby agree to accept HEI students to undergo practicum / internship at its facilities and / or offices.

NOW, THEREFORE, for and in consideration of the foregoing premises, HEI and RURAL BANK OF HINDANG (LEYTE), INC., agree and stipulate the following:

A. HEI shall endeavor to:

- 1. Provide the RURAL BANK OF HINDANG (LEYTE), INC., a Manual or Plan designed in collaboration with the company or agency;
- 2. Require students to comply the following documents and furnish RURAL BANK OF HINDANG (LEYTE), INC., of such documents:
 - a. Student Profile
 - b. Community clearances (Barangay, Police and NBI clearance)
 - c. Medical certificate
