



CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

This Agreement entered into by and between:

The **VISAYAS STATE UNIVERSITY**, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700 and converted into a state university by virtue of Republic Act No. 9158 and renamed as Visayas State University by virtue of Republic Act No. 9437, with principal office at Baybay City, Leyte, duly represented by its President **EDGARDO E. TULIN**, hereinafter referred to as the **FIRST PARTY**;

-and-

Engr. CLINT C. SARVIDA and Engr. ERIC E. SAJULGA, of legal age, Single/Married, Filipino and with residence and postal address at Brgy. Dulho, Bato Leyte, Cabadbaran City, Caraga hereinafter referred to as the **SECOND PARTY**;

WITNESSETH:

WHEREAS, the **FIRST PARTY** is in need of persons who possesses the necessary technical know-how and license issued by the Philippine Regulations Commission to practice the professional Electrical Engineering and who can provide the needed services which can no longer be performed by the existing manpower/employees of the Physical Plant Office of the university;

WHEREAS, the **SECOND PARTY**, possesses the required qualification and expertise needed and is willing to provide the services needed;

NOW, THEREFORE, premises considered, the parties hereto hereby agree as they have agreed under the terms and conditions, as follows:

The **FIRST PARTY** hereby contracts the services of the **SECOND PARTY** as Electrical Engineers to perform the following functions and to wit;

1. Prepares electrical plants, designs and cost estimates for the proposed new buildings for submission to DBM and other regulatory bodies for funding.
2. Inspects the existing electrical installations of existing buildings, streets, parks, playing parks and prepares proposed plants, electrical designs project costs estimates for the rewiring of these buildings of the university
3. Supervises on-going construction projects and other structures involving electrical installations to ensure compliance with the Building Code and Fire Code of the Philippines
4. Performs addition duties and functions as may be assigned by either superiors, vice President for Administration & the President.

THAT the **SECOND PARTY** shall abide by the rules and regulations of the **FIRST PARTY** and the terms and conditions as provided for in this service contract and performs the above-listed functions and additional functions as may be assigned from time to time;

THAT for and in consideration of the foregoing service, the **FIRST PARTY** binds itself to pay each member of the **SECOND PARTY** in the amount of **PhP 33,584.00 per month plus 20% premium** to be paid per quincena upon presentation of a certification of accomplishments issued by the **FIRST PARTY** or his duly authorized representative;
