6. Midyear extension progress reports every 1<sup>st</sup> week of July every year.
7. Present the research highlights or papers during the Research In-House Review and Evaluation.
8. Present a paper in the regional/ national R&D Symposia/fora (*as scheduled by Consortium/National agency concerned with prescribed standard format*).
9. Submit the terminal report three (3) months after completion of the research project.
10. Publish articles of significant findings in indexed/peer-reviewed journals.

In case of any changes in the title, methodology, project site, and/or budget, approval should first be sought from the University President upon recommendation by the concerned College Dean, Director for Research, and the Vice President for Research, Extension, and Innovation.
