Dear Dr. Tulin:

Good day to you!

I am Myr Vhene Vencent A. Delos Santos a BSCE-2 Student humbly appealing to your good office to allow me to pursue my studies in Visayas State University starting this 2nd semester year 2021-2022.

I stopped studying last 2021-2022 1st semester because my father died last year .I know that this is not an acceptable reason Sir, but I've got really hurt, I can't handle the pain, and I really don't know what to do after knowing that my father, Ruben V. Delos Santos, is already dead on March 31st of 2021 in Our Lady of Lourdes Hospital in Manila due to Covid-19 and other complications and that, his death was hidden from us by my cousins in Manila and just discovered the truth that my father is already dead on April 20, 2021 from others.

On April 23, 2021,my sister and me arrived in Manila to confirm his death, however, my cousins are initiating that he is still alive and just resting in BF homes Paranaque. We tried to visit my Papa in Paranaque, but they told us that we are not allowed to visit him due to Covid-19 restrictions. We are exerting all effort amidst Covid-19 restrictions just to confirm his death. First, we reached out to 3 PAO lawyers then 2 Private lawyers to ask assistance on what should be the next step for us to file a case against my cousins and they all said, we need documents like his death certificate and the problem is we don't have a copy of his death certificate. Second, we went to the hospital, but only confirmed to us on our second visit that his body was released on April 2 and received by my Aunt. We are asking the hospital to release a copy of my father's death certificate by writing a formal letter and asking them personally, but they said that are only allowed to release it once. Third, we went to the Civil Registry of Manila to get a copy of his death certificate, but we discovered that they didn't register his death yet since they are hiding my Papa's death to everyone and it is already a month of May. My sister and me are always out to know what really happened

and to further confirm his death, since we don't have any documents for us to file a case against them and the hospital also don't want to give us a copy because maybe, my cousins have connections there. We needed documents during that time because we want to file a case against my cousins and with that, I can't attend my classes because my sister and me is always out asking help from friends and others who knows my father.

Sir as I am not on my right mind during that time due to unexplained pain I'm feeling and just lost interest to everything for what my relatives have done to me, where in fact, treated me good when my father is still alive. And I wanted to be honest Sir that during that time, filing the Leave of Absence didn't occur to me. It is as if, I no longer want to finish my study since Papa is no longer here to be with me once I graduated as he is the only one pushing me to finish my studies.

I would like to enroll this A.Y 2021-2022 2nd semester to continue my studies I know it is too late but if I were given a chance I will do my best to pass all the subject that I will take.

Realizations hit me Sir and I know that Papa's wish, is for me to graduate in college and I will promise that I will continue and do well in my studies for my self and my family.
