BAC Resolution Recommending for Approval the Award of Contracts to Pixelmax Printing & Imaging Solutions, Palm Photo & Printshop, KNC Baybay Printing House, and Liong Garments with Total Amounts of Fourteen Thousand Five Hundred Pesos (PhP 14,500.00), Seventeen Thousand Eight Hundred Fifty Pesos (PhP 17,850.00), Sixteen Thousand Four Hundred Seventy-Five Pesos (PhP 16,475.00) and One Hundred Nine Thousand Two Hundred Pesos (PhP 109,200.00), respectively, for the Procurement of Office Supplies/Tokens through Negotiated Procurement – Small Value Procurement Modality

WHEREAS, a Purchase Request No. STF-2024-07-0001-E from the OVPA for the procurement of office supplies/tokens with total approved budget for the contract (ABC) of One Hundred Seventy-Three Thousand Five Hundred Pesos (PhP 173,500.00) was submitted to the Procurement Office;

WHEREAS, as a general rule, all procurement shall be done through Competitive Bidding unless justified by the conditions provided in RA 9184 and its Revised IRR, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement;

WHEREAS, Annex H(V)(D)(8) of the 2016 Revised IRR of RA 9184 provides that the Procuring Entity may resort to Negotiated Procurement - Small Value Procurement if the Approved Budget for the Contract (ABC) does not exceed One Million Pesos (PhP 1,000,000.00);

WHEREAS, the Procurement Office prepared and posted a Request for Quotation (RFQ) in the PhilGEPS, in the VSU Website, and in the VSU Procurement Bulletin Board for three (3) calendar days and invited at least three (3) prospective bidders to quote for this procurement project;

WHEREAS, in response to the said postings of the RFQ, four (4) bidders were obtained as follows: (1) **Pixelmax Printing & Imaging Solutions**, (2) **Palm Photo & Printshop**, (3) **KNC Baybay Printing House**, and (4) **Liong Garments**, and their quotations were tabulated in the Abstract of Bids;


WHEREAS, the BAC with the Technical Working Group evaluated the quotation of each bidder and recommended for award of contract to the bidder with the lowest single calculated and responsive bid per item as shown in the Abstract of Bids; (*see attached Abstract of Bids*)



NOW THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To recommend for approval the award of contract to **Pixelmax Printing & Imaging Solutions** with a total amount of **Fourteen Thousand Five Hundred Pesos (PhP 14,500.00)**;
2. To recommend for approval the award of contract to **Palm Photo & Printshop** with a total amount of **Seventeen Thousand Eight Hundred Fifty Pesos (PhP 17,850.00)**;
3. To recommend for approval the award of contract to **KNC Baybay Printing House** with a total amount of **Sixteen Thousand Four Hundred Seventy-Five Pesos (PhP 16,475.00)**;
4. To recommend for approval the award of contract to **Liong Garments** with a total amount of **One Hundred Nine Thousand Two Hundred Pesos (PhP 109,200.00)**; and
5. To recommend for approval by the **VSU President** with the Delegated Authority the foregoing findings.
