

Description: The AFPSAT is an aptitude test that is utilized in the initial recruitment and selection process in the AFP. It has three sub-tests: Abstract Reasoning (AR), Verbal Reasoning (VR) and Numerical Reasoning (NR).

- AR is a non-verbal, non-numerical measure of reasoning power. It measures the ability to see relationships among things — objects, patterns, or designs — rather than among words and numbers.
- VR measures the ability to reason and solve problems through the concept of words by comprehension, grammar and vocabulary recognition.
- NR measures the ability to reason and solve problems with numbers, and other mathematical concepts.
