Dear Dr. Ferraren:

We are pleased to share with you the results of the CPES Accreditation Training conducted during the CPES Accreditation Training on 23-25 November 2022 held in the Training Room of the Visayas State University (VSU). The lectures were delivered during the first day of the training, followed by Case Study Exam on the second day, and the practicum on the third day wherein the participants visited the *Multi-Purpose Building (Sports Complex) Project* located in Baybay City, Leyte using the CPES checklist.

The participants showed strong interest to apply CPES in the implementation of infrastructure projects. During the training, the participants' interest and enthusiasm were manifested in the actual project evaluation conducted. They took the practicum session very seriously.

The participants gave an overall "Very Satisfied" rating to the training conducted, course design, training objectives, and resource speakers. Details of their training evaluation are shown in "Annex A".

Based on our evaluation, a total of fourteen (14) participants took the case study exercise and passed the same. The case study forms part of the 3-day training in compliance with the basic requirements for accreditation as Constructors' Performance Evaluators (CPEs).

- Project Management /Supervision/Monitoring;
- Construction Safety/Environmental Assessment; and
- Other related courses


