## SAFETY POLICY

The Manila International Airport Authority (MIAA), with Safety as its paramount priority, commits to develop, implement, maintain and constantly improve strategies and processes to ensure that all aviation activities take place under a balanced allocation of organizational resources, aimed at achieving the highest level of safety performance and complying with the State Safety Program of the Civil Aviation Authority of the Philippines and other international aviation standards.

The Authority is also committed to provide a safe and healthy working environment within an acceptable level of recognized hazards for its employees and customers, embedding a culture of safety among the workforces. To achieve this, senior management shall implement an aerodrome safety management system compliant with the standards set out in the Civil Aviation Authority of the Philippines - Manual of Standards for Aerodromes.

All managers and supervisors are accountable for the safety practices and performance of employees in their areas of responsibility. On the other hand, it is the duty of all MIAA employees, business partners, service providers and stakeholders to comply with the safety requirements, to participate in the program and take an active role in the identification and reduction of hazards. The MIAA is specifically committed to:

- Provide all appropriate resources, including sufficient skilled and trained personnel, necessary for implementing the safety policy;
- Ensure widest dissemination of Safety Policy in order to develop a safety culture across all aviation activities that recognizes the importance and value of effective aviation safety management at all times;
- Minimize the risk associated with an aircraft accident to a point which is AS LOW AS REASONABLY PRACTICABLE;
- Implement mandatory reporting of all incidents, occurrences, hazardous conditions and hazardous behaviors that may compromise safe airport operations;
- Encourage voluntary and confidential reporting of sensitive incidents for the protection of the reporting personnel;
- Ensure that no punitive action is taken against those who shall endeavor to report on safety occurrences;
- Actively develop and improve safety processes to conform with national and international standards;
- Establish and measure our aviation safety performance against objectives and/or targets; and,
- Continually improve safety performance through the conduct of periodic safety and management reviews


