To pass the Licensure Examination for Agriculturists, a candidate must obtain a weighted general average grade of at least seventy-five (75%) percent with no grade lower than sixty (60%) percent in any given subject. An examinee who obtains a weighted general average grade of seventy-five (75%) percent or higher but obtained a rating below sixty (60%) percent in any given subject/s may be allowed to take a removal examination in the subject/s where he obtained a grade below sixty (60%) percent. The removal examination shall be allowed only once.

An examinee who fails to pass the examination for the third time shall be allowed to take another examination only after said examinee has taken a six months refresher course in the fields of specialization in Agriculture where he/she failed once, twice or three times organized by a school or college of Agriculture established or recognized by the Government. The three-time flunker shall not be allowed to take the examination unless he/she presents or submits a certification under oath issued by the authorized official of the school or college of Agriculture certifying that the three-time flunker has successfully completed the refresher course. For purposes of determining the three (3) failures, the first examination and the removal examination shall be considered as one examination.

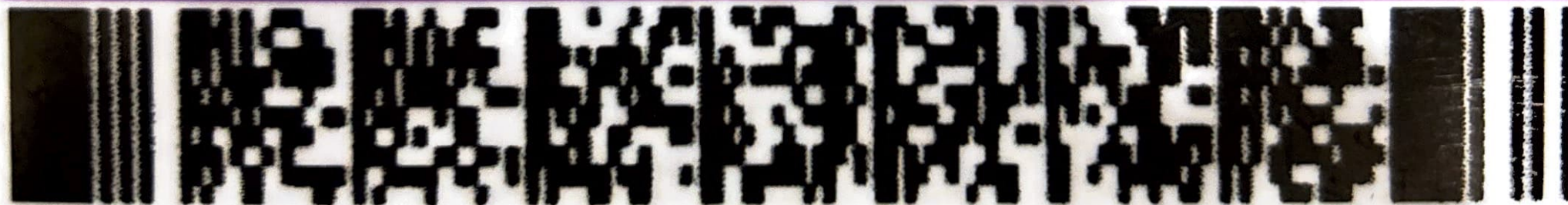

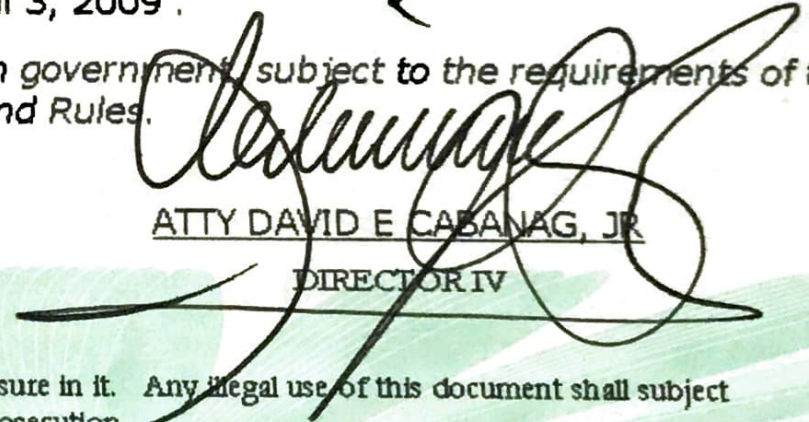
