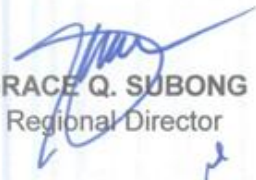
This order is issued to support their travel claims in lieu of Travel Order. It is understood that travels made outside of their Area of Assignment must be supported by a Travel Order.
