CONTRACT OF SERVICE

KNOWN ALL MEN BY THESE PRESENTS:

This contract is made and entered by and between:

The **NATIONAL FOOD AUTHORITY**, a government owned and controlled corporation with office address at Pawing, Palo, Leyte, herein presented by **GERARD V. LIM**, OIC-Regional Manager II, herein referred to as **FIRST PARTY**.

- and -

MR. REYNAND E. CORPUZ, of legal age, a Filipino and with residence address at Purok 6 Barangay Pa-a, Hilongos, Leyte herein referred to as the **SECOND PARTY**.

WITNESSETH:

1. That the **FIRST PARTY** is in need of services of the **SECOND PARTY** who shall perform works in the Quality Assurance Section of the **FIRST PARTY**;
2. That the **SECOND PARTY** has signified his intention to which the **FIRST PARTY** has accepted, to provide the services needed by the latter;
3. That the **SECOND PARTY** hereby possess the education, experience and skills required to perform the job as described herein;
4. That the **SECOND PARTY** hereby attests that he is not related within third degree (fourth degree in case of LGUs) of consanguinity or affinity to the (1) Hiring Authority and/or (2) Representative of the **FIRST PARTY**, that he has not been previously dismissed from the government service by reason of an administrative offense, that he has not already reached the compulsory retirement age of sixty-five (65);
5. That in view hereof, the **SECOND PARTY** is hereby contracted as **CHEMIST I**, on a **PIECEMEAL CONTRACT**, of NFA Regional Office 8 assigned at the **QUALITY ASSURANCE SECTION** for **Six (6) months from July 1, 2024 to December 1, 2024** in consideration of the monthly rate of **TWENTY-SEVEN THOUSAND PESOS** to assist the RSQAO in the conduct of Laboratory Analyses of Palay and Milled Rice and perform other tasks that may be assigned to him.
6. That the **SECOND PARTY** shall perform work at a time and schedule to be agreed upon by both parties;
7. That it is understood that this contract does not create an employer-employee relationship between the **FIRST PARTY** and the **SECOND PARTY**; that the services relationship hereunder is not considered and will not be accredited as government service; and that the latter is not entitled to benefits enjoyed by the regular personnel of the **FIRST PARTY**.
