EDGARDO E. TULIN, hereinafter referred to as the FIRST PARTY;

## WITNESSETH:

WHEREAS, the FIRST PARTY is in need of persons who can provide support services that cannot be performed by the existing regular manpower/employees of the specific units/departments/centers within the university;

WHEREAS, the SECOND PARTY, possesses the required qualification and expertise needed by the hiring department/center/unit/office and is willing to provide the services needed;

NOW, THEREFORE, premises considered, the parties hereto hereby agree as they have agreed under the terms and conditions, as follows:

THAT the SECOND PARTY shall perform the functions and deliver the following outputs as follows:

- a. Prepares faculty report of actual teaching load and individual faculty workload.
- b. Coordinates office and administrative activities particularly storing, retrieving and integrating information.
- Disseminates department meetings and seminars.
- d. Receives and relays IP messages and telephone calls for faculty and staff.
- e. Maintains and record filing system of the office.
- f. Facilitates the faculty members in using the cumulus website for encoding and printing of grades sheets and class rosters.
- g. Maintains cleanliness and orderliness of the office and reception area.
- h. Performs other functions as assigned by the department head.

THAT the SECOND PARTY shall abide by the rules and regulations of the FIRST PARTY and the terms and conditions as provided for in this service contract;

THAT the SECOND PARTY shall perform the above-listed functions for a total of Twenty One (21) days per month at not less than <u>six</u> (6) hours per day based on the work schedule as prescribed by the hiring department/office/center/unit;

THAT for and in consideration of the foregoing service, the FIRST PARTY binds itself to pay the SECOND PARTY in the amount of Php 9,659.35 per month.

THAT the SECOND Party will be paid twice a month (per quincena) upon presentation of a certification of accomplishments and rendition of actual services issued by the FIRST PARTY or its duly authorized representative. The total amount of payment shall be adjusted should the SECOND PARTY fail to meet the maximum number of days and hours of service. The above payments will be charged to General Fund;
