
Pursuant to the provisions of Presidential Decree No. 907 promulgated by President Marcos on March 11, 1976, you are hereby declared a civil service eligible. Under the Decree, you shall be considered -

- a. A First Grade eligible if you are employed in a position which requires the application of knowledge and skills within your field of study;
- b. A Second Grade eligible if you are employed in a position outside of your field of study.

If you hold a Bachelor's degree in Education or Elementary Education and you are employed as teacher in the public schools, you shall be considered a Teacher eligible.
