Proposed Interventions to sustain/improve Performance:

Full support from the Department of Soil Science, the College of Agriculture and Food Sciences and from the University in terms of financial support for the purchased of high -end computers to meet the current needs of our students in this new normal. Going online for instruction and other activities would require stable internet connectivity and power supply.
