#### Purpose

 The purpose of this minute is to seek your approval to commit relevant money and enter into an arrangement valued at A\$375,581.64 plus GST with Kathleen Mae Valencia for an Australia Awards Scholarship to study at The University of Queensland.

#### Background

- The selection was undertaken on the principles of transparency, equity, open competition and merit. The final selection process was chaired by a senior ACIAR officer taking account of all prior eligibility requirements before finalising the outcome. The selection outcome report has been approved by the appropriate delegate at post or desk.
- Kathleen Mae Valencia was successful through this rigorous and transparent process, and it is
  recommended that a scholarship be offered and for ACIAR to cover the majority of scholarship
  costs.

#### 1. Definitions

#### 2. Australia Awards Scholarships Policy Handbook

- 2.1. I have read and understood the Australia Awards Scholarships Policy Handbook and understand that DFAT reserves the right to change the Australia Awards Scholarships Policy Handbook at any time and that any changes may affect the conditions of my Scholarship.
- I agree to comply with my obligations outlined in the Australia Awards Scholarships Policy Handbook as updated from time to time.
- 2.3. - b. participate in the pre-departure briefing arranged by the DFAT Post and participate in the Institution's compulsory Introductory Academic Program when I arrive in Australia;
- undertake only the approved course of study for which the Scholarship is offered, abide by the rules of the Institution, submit all assessment items required for the course and sit

examinations, and complete my course of study and the Scholarship by the end date specified in Schedule 1;

- d. obey the laws that apply in Australia and act in a manner that will not bring disrepute to ACIAR; and
- e. leave Australia for a minimum of two years at the end of, or termination of, my Scholarship and I acknowledge that any time spent in Australia during the two year exclusion period will extend the end date of the exclusion period.
- 3.2. For the duration of the Scholarship I must:
  - a. maintain a full time program of study at all times unless approved by ACIAR;
  - b. make satisfactory academic progress as determined by the Institution;
  - reside in Australia for the duration of the Scholarship (apart from holidays, reunion visits or fieldwork visits which have been approved by ACIAR);
  - maintain a clear and direct line of communication with ACIAR through the Student Contact
    Officer, recognising that the Student Contact Officer is the first point of contact for my
    dealing with ACIAR; and
  - e. work with ACIAR and the Student Contact Officer if a welfare or critical incident occurs.

#### 4. Visa

- 4.1. I agree to satisfy all visa requirements determined by the Australian Department of Home Affairs to hold a Foreign Affairs or Defence Sector (Subclass 500) Visa, as set out at: http://www.homeaffairs.gov.au.
- 4.2. I acknowledge that the Australian Department of Home Affairs issues visas for entry into Australia and that ACIAR can provide support for certain visas but has no control over visa decisions made by the Department of Home Affairs.
- 4.3. I will not apply, including as part of a joint or family application, for a visa other than the Foreign Affairs or Defence Sector (Subclass 500) Visa for the duration of my Scholarship, and I acknowledge that if I do then my Scholarship will be terminated, and I will incur a debt to the Commonwealth of Australia of the total accrued cost of my scholarship.

#### 5. Financial obligations

5.1. I acknowledge that I am responsible for all costs that occur during my Scholarship period that are not covered by the Scholarship benefits.

- 5.2. I acknowledge that I am responsible for how I budget any Scholarship benefits I receive to pay my living expenses.
- 5.3. I agree to repay all Scholarship benefits I receive, as a debt due and owing to the Commonwealth of Australia if:
  - a. I do not leave Australia at the end of my Scholarship; or
  - b. if I apply for anything other than a short-term temporary visa to return to Australia within two years of completion of my Scholarship.

#### 6. Medical expenses

6.1. I acknowledge that my Overseas Student Health Cover (OSHC) may not cover all medical expenses, and that I am liable for any additional expenses incurred by me and my dependants during my Scholarship.

#### 7. Other scholarships and studies

- 7.1. I will not hold another Australian Government scholarship, other than an ACIAR supplementary award, at the same time as the Australia Awards Scholarship, or begin studying another course.
- 7.2. I will not undertake any additional off scholarship studies during my time in Australia on the Foreign Affairs or Defence Sector (Subclass 500) Visa.

#### 8. Change of circumstances

- 8.1. I will advise ACIAR immediately, via the Student Contact Officer at the Institution, of any personal, financial or family circumstances or incidents (e.g. family or financial problems, medical conditions, etc.) that might affect my ability to commence the Scholarship on time or to complete the approved course of study within the Scholarship period.
- 8.2. I will advise ACIAR immediately, via the Student Contact Officer at the institution, if I marry a person who is an Australian or New Zealand citizen, or is a permanent resident in Australia or New Zealand. I acknowledge that I need to comply with the Scholarship conditions and my visa conditions even if my marital status changes.

#### 9. Changes to Scholarship or course of study

- 9.1. I will discuss with the Student Contact Officer at the Institution any proposed changes to the approved course of study for which the Scholarship is offered.
- 9.2. I will obtain approval from the Institution, ACIAR and, in some instances, the partner government before making any changes to my course of study.

- 9.3. I acknowledge that ACIAR may amend the period of my Scholarship or Scholarship benefits at its discretion.
- 10. Termination and Suspension of Scholarship
  - 10.1. I acknowledge that I hold the Australia Awards Scholarship with ACIAR's support and ACIAR reserves its right to terminate the Scholarship and withdraw its support at any time, including if I:
    - a. do not comply with a condition of the Scholarship;
    - do not make successful academic progress and remedial strategies have not been successful;
    - am excluded by the Institution from my course or study units due to academic failure or from remaining at the Institution because of misconduct (as defined by the institution);
    - complete the maximum period of English language training available under the scholarship and still have insufficient English language ability for entry to my course of study;
    - e. am unable to continue a program due to serious illness or incapacity for medical/mental health reasons;
    - f. conduct myself in a manner which is considered to have transgressed acceptable Australian community standards;
    - g. apply for a visa other than the Foreign Affairs or Defence Sector (Subclass 500) Visa; or
    - h. am found guilty of a crime.
  - 10.2. I acknowledge that ACIAR reserves the right to suspend my Scholarship, including if:
    - a. ACIAR determines that I am unable to continue my course or study; or
    - b. I am unable to continue a course or study due to serious illness or incapacity due to medical or mental health reasons.
  - 10.3. I acknowledge that my Scholarship will be suspended until I can demonstrate that I am able to undertake full time study. I acknowledge that ACIAR will determine when my Scholarship recommences.
  - 10.4. If my Scholarship is suspended I will return to my home country (with any dependents) for the duration of the suspension and will seek the prior approval of ACIAR and the Institution before returning to Australia.

#### SCHEDULE 2 - DFAT's Child Protection Code of Conduct

I, Kathleen Mae Valencia acknowledge that I have read and understand DFAT's Child Protection Policy, January 2017, and agree that in the course of my association with DFAT

#### I must

- treat all children with respect
- not use language or behaviour towards children that is inappropriate, harassing, abusive, sexually provocative, demeaning or culturally inappropriate
- not engage children under the age of 18 in any form of sexual intercourse<sup>5</sup> or sexual activity<sup>6</sup>, including paying for sexual services
- · wherever possible, ensure that another adult is present when working near children
- not invite unaccompanied children into private residences, unless they are at immediate risk of injury or in physical danger
- not sleep close to unsupervised children unless absolutely necessary, in which case the supervisor's permission must be obtained, and ensuring that another adult is present if possible (noting that this does not apply to an individual's own children)
- never use any computers, mobile phones, video cameras, cameras or social media to exploit or harass children, or access child exploitation material through any medium
- · not use physical punishment on children
- not hire children for domestic or other labour: which is inappropriate given their age or developmental stage; which interferes with their time available for education and recreational activities; or which places them at significant risk of injury
- comply with all relevant Australian and local legislation, including labour laws in relation to child labour
- immediately report concerns or allegations of child exploitation and abuse and policy noncompliance in accordance with appropriate procedures
- immediately disclose all charges, convictions and other outcomes of an offence that relates to child exploitation and abuse, including those under traditional law, which occurred before or occurs during association with DFAT
- be aware of behaviour and avoid actions or behaviours that could be perceived by others as child exploitation and abuse

These behaviours are not intended to interfere with normal family interactions.

- take care to ensure local traditions or restrictions for reproducing personal images are adhered to before photographing or filming a child

- ensure images are honest representations of the context and the facts
- ensure file labels, meta data or text descriptions do not reveal identifying information about a child when sending images electronically or publishing images in any form

I understand that the onus is on me, as a person associated with DFAT, to use common sense and avoid actions or behaviours that could be construed as child exploitation and abuse.

# PRIVACY NOTICE AUSTRALIA AWARDS — SCHOLARSHIPS, FELLOWSHIPS AND SHORT COURSES

The Department of Foreign Affairs and Trade (DFAT) manages international Scholarships, Pacific Scholarships, Fellowships and Short Courses funded by the Australian Government that aim to contribute to the long term development needs of Australia's partner countries, in line with global, bilateral and regional agreements.

## What types of personal information is collected?

Below are examples of the personal information DFAT may collect:

- Letters of offer and acceptance documentation
- Personal details, for example gender, date of birth, country of origin, identification numbers, etc.
- Prior academic qualifications (transcripts and history)
- Current and previous employer details
- Professional memberships or associations
- Criminal history
- Personal passport information
- Visa information
- Banking information to pay entitlements
- Residential and mailing addresses in home country and while studying in Australia
- English test scores (IELTS, etc.)
- Contact details, including telephone numbers and email addresses
- Medical assessments
- Disability assessments and supporting documentation
- Personal details of accompanying dependants (or Carers), including all of the above as required
- Other information related to your Australia Award Scholarship, Fellowship or Short Course

# Why is your personal information collected?

The purpose of collecting this information is for the management, promotion and evaluation of the Australia Award program. Information is also collected to ensure DFAT upholds its obligations while you are in participating in the Australia Awards program.

This information may also be used to contact you after the completion of your Australia Award by DFAT or a contracted service provider of DFAT, to follow up on your experiences and achievements and how your Australia Award may have contributed to this.

# When we collect your personal information from others

If we need to collect information from a third party, e.g. a medical practitioner, we will first obtain your consent.

# What happens if we do not collect your personal information?

If DFAT does not or is unable to collect personal information from you we may not be in a position to consider your application for an Australia Award Scholarship, Fellowship or Short Course, provide you with relevant access, or provide guidance regarding conditions relevant to these Awards.

# Who will your personal information be disclosed to?

DFAT may disclose your personal information to third parties, for the purpose of managing, promoting or evaluating the Australia Awards. For example, your personal information may be disclosed by DFAT to, the following parties:

- · the Australian Taxation Office
- the Australian Public Service Commission
- Higher Education Institutions (for example, Student Contact Officers)
- other Commonwealth agencies
- your nominated representatives, authorised agent or embassy or High Commission in Australia
- agents, contractors or service providers engaged by DFAT to carry out or assist its functions and activities (such as a Global Tracer Facility for survey work and case studies of Australia Award alumni)
- medical professionals (in the case of a Welfare incident)

You also consent to DFAT disclosing your personal information to overseas recipients, that is, individuals or entities who are not in Australia. You acknowledge that you understand DFAT will not take any steps to ensure that an overseas recipient does not breach an Australian Privacy Principle under the *Privacy Act 1988*.
