- Retain the a VSU Fellowship Grant throughout the period unless compelled to withdraw for urgent reasons and upon approval of the GRANTOR;
- Accept no other kind of a VSU Fellowship Grant without clearance from VSU. If the grantee is able to avail of another scholarship grant, his shall refund the amount you availed from VSU starting from the date of effectivity of the other scholarship.
- Maintain a semestral grade point average acceptable to the graduate school and submit a progress report of his studies as basis for the yearly renewal of the grant;
- Return to service shall only commence after completion of the degree subject of this grant. In case of health reasons and other justifiable causes, return to service may be temporarily allowed upon recommendation of the adviser and the Dean of Graduate School where the Grantee is studying, said service, however, shall not be considered as partial compliance of the GRANTEE's service obligation;
- Return to VSU immediately at the end of the semester when his studies or course under the GRANT is completed. Should the grantee fail to return to service during the summer term immediately preceding his completion of the degree will mean that said absences will be WITHOUT PAY unless the GRANTEE has leave or service credits where his absences will be charged. Summer vacation pay is only granted to faculty members in active service as teachers for the full two semesters preceding the summer vacation.
