**APPROVING THE REQUEST FOR AN AUTHORITY TO DECLARE FAILURE OF THE PROJECT ENTITLED "CONSTRUCTION OF CENTENNIAL TWO-STOREY LANDMARK BUILDING (VSU-INFRA-23-03)" WITH A TOTAL ABC OF P10,000,000.00 IN COMPLIANCE TO THE IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184**

**Whereas**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**Whereas**, the BOR passed resolution No. 10, s. 2023, approving JV Enterprises as the Bidder with the Lowest Calculated and Responsive Bid in the amount P9,949,994.73 for the Construction of Centennial Two-Storey Landmark Building (VSU-INFRA 23-23) Project;

**Whereas**, due the circumstances such as change of leadership, the project was not implemented as to its specified timeline;

**Whereas**, the timeline of procurement activities for the project has already lapsed as it already reached 303 days, 167 days beyond the maximum allowable period for competitive bidding of goods and services of 136 calendar days;

**Whereas**, to comply with the implementing rules and regulations of RA 9184, the University President proposed to declare failure of project due to lapse of time allowed for competitive bidding of goods and services;

**Whereas**, the university management requests for an authority to realign the funds to another infrastructure project that would be more useful for the attainment of goals and objectives of the University and in the delivery of quality service to its clientele;

**Whereas**, the proposal was presented to the University Administrative Council at its meeting on May 23, 2024 and obtained favorable endorsement;

**Whereas**, finding the UADCO's recommendation in order, the Governing Board has agreed to approve the proposal;

**Now, therefore**, on motion, duly seconded, and unanimously approved, be it;






