The functions of the Committee are as follows:


1. To assist the Academic Personnel Board in formulating an effective staff development program based on the requirements and staff patters of the various academic units.

sabbatical assignments that require allocation of resources and/or official sanction by the University President and recommend action through the Academic Personnel Board.

5. To perform other functions related to scholarship/fellowship that may be assigned by the President.
