The Government Association of Certified Public Accountants, Inc. (GACPA), one of the largest sectoral organization of Certified Public Accountants (CPAs) in government service and which is also under the umbrella of the Philippine Institute of Certified Public Accountants (PICPA) will hold its **42nd Annual National Convention & Seminar (ANCS)** from May 26 to 29, 2020 at the ASEAN Convention Center, Clark Field, Pampanga.

With this year's theme "Reinforcing the Future Together Today", the GACPA Board of Directors had prepared technical sessions on topics related to Revised Rules on Administrative Cases, Philippine Development Plan, Gender Awareness, Rules and Regulations on the Settlement of Accounts, Integrity Management Program, Ease of Doing Business and Efficient Government Service, and Updates from the Board of Accountancy. Likewise, topics on health and wellness and the TRAIN Law will highlight the technical sessions of the annual convention.

We have invited resource speakers from the public and private sectors who are competent in their respective field of expertise. Attendance to the ANCS shall entitle the participants with **Continuing Professional Development credit units** in order to comply with the requirements of the Board of Accountancy and/or PRC in the renewal of CPA License and accreditation as practitioner.

We are cordially inviting the CPAs, Accountants, Budget Officers, Disbursing Officers, Finance Officers, Auditors and Administrative Officers in your agency to attend the GACPA 42nd ANCS.

The registration fee is **EIGHT THOUSAND Pesos (P8,000.00)** per participant for the 4-day conference. Pursuant to **DBM Circular No. 563, dated April 22, 2016**, payments of this nature including incidental expenses are chargeable against the agency funds.

Delegates are advised to pre-register online through the link posted at the GACPA Website. Payment for registration fee should be deposited to **GACPA, INC., Savings Account No. 0581-1560-22, LBP Aurora, Cubao Branch**. Registrant should upload a copy of the deposit slip/LDDA/ADA when pre-registering on-line and **need not send them through fax or email**. Delegate will receive the first e-mail that the on-line pre-registration is pending until confirmation of the deposit of the registration fee. The second email will state that the pre-registration for the 42nd ANCS has been accepted and delegate should print the PDF ticket and present at the Registration Desk on May 26, 2020. Issuance of Convention Kit is on a **"first come first served basis."** The deadline to register with payment is **on or before April 30, 2020**. Walk-in participants will also be accommodated in the venue. However, GACPA reserves the right to refuse the registration of those who may no longer be accommodated in the venue.

Thank you for your continued support to the objectives of GACPA. We look forward for a fruitful knowledge sharing with you and your representatives at the ASEAN Convention Center, Clark Field, Pampanga.
