R E: Expansion of the Anti-Sexual Harassment Committee/Committee on Decorum and Investigation

By virtue of the authority vested in me by the VSU Board of Regents, the Anti-Sexual Harassment Committee/Committee on Decorum and Investigation (ASHC/CODI) is hereby reconstituted for a two year period commencing on April 16, 2021.

The ASHC/CODI has the following functions:

- 1. Received complaints of sexual harassment or other related sexual offenses;
- Investigate complaints of sexual harassment or other related sexual offenses in accordance with the prescribed procedure both in the preliminary and formal investigations;
- 3. Submit a report of its findings with the corresponding recommendations to the disciplining authority for decision;
- Lead in the conduct of discussions about sexual harassment and other related sexual
 offenses within the institution to increase the community's understanding of, and
 prevent incidents of sexual harassment and other related forms of sexual offense; and
- 5. Conduct such other activities that would engender a safe environment for women in school campuses and training-related programs in HEIs.
