4. Supervise and coordinate with the different academic departments under the Faculty in the offering of undergraduate and graduate programs to produce globally competitive graduates.
5. Initiate and monitor the conduct of RDE projects of the Faculty and its academic departments.
6. Spearhead the implementation of Faculty-wide activities including but not limited to seminar-workshops, RDE In-house Review, Faculty-wide meetings, and Management Committee Meetings.
7. Supervise and spearhead the implementation of OBE curriculum in the Faculty.
8. Monitor the utilization of Faculty funds and its expenditures, and
9. Represent the Faculty in all university activities.

As Dean, you are entitled to the privileges granted and the responsibilities attached to the position subject to pertinent policies.

This designation will take effect on **January 2, 2025 until December 31, 2025** or unless sooner revoked.
