**CONFIRMING THE MEMORANDUM OF AGREEMENT/ MEMORANDUM OF UNDERSTANDING MADE AND ENTERED BY VISAYAS STATE UNIVERSITY WITH VARIOUS AGENCIES AND INSTITUTIONS**

**Whereas**, the Board of Regents is granted the power to develop consortia and other forms of linkages with local government units, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University;

**Whereas**, as provided by law, the Board of Regents could delegate the above-mentioned power to the University President as it may deem appropriate, so as to expedite the administration of the affairs of the University;

**Whereas**, Board Resolution No. 14, s. 2006 which granted the University President authority to approve and sign contracts/agreements with other institutions, local or foreign, for joint academic, research and/or training programs; provided no additional and/or special budgetary outlay on the part of the university is involved; provided further those contracts/agreements be reviewed by the legal counsel and concerned officials of the university and be submitted to the board for confirmation;

**Whereas**, the above-said agreements with various agencies and institutions, summarized in a list hereto attached, have been forged through the University President;

**Whereas**, the University Administrative Council favorably endorsed confirmation of said agreements in its meeting on May 23, 2024;

**Whereas**, finding the UADCO's recommendation in order, the Governing Board has agreed to confirm the MOA/MOU submitted;

**Now, therefore**, on motion, duly seconded, and unanimously approved, be it;


