APPROVING THE REQUEST FOR AN AUTHORITY TO DECLARE FAILURE OF THE PROJECT. "SUPPLY DELIVERY AND INSTALLATION OF GENERATOR SETS FOR VSU POWER PLANT" WITH THE AMOUNT P33,011,000.00 DUE TO NON-OBSERVANCE OF THE REQUIRED 136 CALENDAR DAYS FOR THE COMPLETION OF WORKS FOR COMPETITIVE BIDDING OF GOODS AND SERVICES AND RESOLVING FURTHER TO AUTHORIZE THE UNIVERSITY PRESIDENT TO COMMENCE RE-BIDDING PROCESS AS PRESCRIBED IN REPUBLIC ACT NO. 9184 AND ITS IMPLEMENTING RULES AND REGULATIONS AS WELL AS THE EXISTING BUDGETING AND ACCOUNTING RULES AND REGULATIONS OF THE GOVERNMENT

Whereas, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

Whereas, BAC passed Resolution No. CB-48, s. 2023 dated December 7, 2023, declaring Fil Power Group and Marketing Corporation as the bidder with the Single Calculated and Responsive Bid for the Supply, Delivery and Installation of Generator Sets for VSU Power Plant:

Whereas, the proposal was deliberated by the BOR-Finance Committee during its meeting on January 16, 2024;

Whereas, after thorough deliberation on the matter, Regent Rosales expressed that she had no objection with the procurement of generator sets as these are important to the university but asserted that these units should not be delivered without a physical building to house them so as not to expose them to elements;

Whereas, the BOR FC deferred endorsement of the proposal to the Governing Board;

Whereas, RA 9184 requires a maximum of 136 calendar days for the completion of works for competitive bidding of goods and services;

Whereas, the project has already lapsed at it reached 159 days, 23 days beyond the allowable 136 calendar days thus IRR of RA 9184 was not observed;

Whereas, the University President proposed to declare failure of procurement activities for the project as it did not adhere to rules, as mandated by law, on competitive bidding of goods and services:

Whereas, to demonstrate VSU's commitment toward procurement effectiveness, a request for an authority to commence re-bidding process pursuant to Republic Act 9184 is also proposed:

Whereas, finding the UADCO's recommendation in order, the Governing Board has agreed to approve the proposal;

Now, therefore, on motion, duly seconded, and unanimously approved, be it;

Resolved, as it is hereby resolved, that the Board of Regents of Visayas State University declares failure of the project, "Supply Delivery and Installation of Generator Sets for VSU Power Plant" with the amount P33,011,000.00 due to non-observance of the required 136 calendar days for the completion of works for competitive bidding of goods and services and further authorizes the University President to commence re-bidding following the processes prescribed in Republic Act No. 9184 and its implementing rules and regulations as well as the existing budgeting and accounting rules and regulations of the government.
