Specifically, the committee is tasked to do the following:

- 1) Prepare guidelines that are compliant with CHED, DOH, and IATF for the limited face-to-face classes in the second semester SY 2021-2022 for selected courses as prescribed by CHED:
  - a) Bachelor of Science in Nursing
  - b) Doctor of Veterinary Medicine
  - c) Bachelor of Science in Agriculture and Biosystems Engineering
  - d) Bachelor of Science in Civil Engineering
  - e) Bachelor of Science in Mechanical Engineering
  - f) Bachelor of Science in Geodetic Engineering

- 2) Develop mechanism for entry of students enrolled in the selected courses as well as their stay in the dormitories/cottages inside the campus.
- 3) Develop flexible curriculum for the selected courses suited for students and faculty.
- 4) Comply requirements prescribed by CHED for limited face-to-face classes and submit them to CHED for inspection and approval.
- 5) Do other instructions assigned by this Office from time to time regarding this matter.
