The Technical Working Group (TWG) during the conduct of the National Public Hearing/Consultation on the draft "Revised Policies, Standards and Guidelines (PSGs) on Undergraduate Student Internship Abroad Program held on March 15, 2023 has reiterated the memorandum pertaining to the temporary suspension of SIAP.

Pursuant to CHED COVID Advisory No. 7, CHED Memorandum Order (CMO) No. 22, s. 2013 "Revised Policies, Standards and Guidelines (PSGs) on Student Internship Abroad Program (SIAP)" and by virtue of CHED Commission en Banc (CEB) Resolution No. 396-2020 dated 23 June 2020, the following are hereby adopted:

- The SIAP shall be temporarily suspended for Academic Year (AY) 2020-2021. As such, all applications for SIAP for the said academic year shall no longer be processed nor accepted.
- 2. This temporary suspension does not cover the internship program of the Maritime Education.
