

This is to inform you that, we have restored our good image and relationship with the Regional SeedNet. All the seeds that we produced have passed both the field evaluation and laboratory test. We have surpassed the 100 cavans average yield per hectare, which is equal if not, better than the other SeedNet members. This is because of the efforts of Dr. Alfredo B. Escasinas.

In this connection, I would like to request the following:


1. For you to officially request the Regional Executive Director of DA-RFU 8 to transfer the Seed Grower accreditation from Dr. Rodrigo F. Sebidos to Dr. Alfredo B. Escasinas. The endorsement of Director Leo P. Cañeda is required by BPI-Manila to effect such transfer because the accreditation of Dr. R.F. Sebidos has not yet expired. Dr A.B. Escasinas has already attended a training for Seed Growers accreditation
2. For the Property Officer to be authorized to transfer all VSU properties from the ATEP building to the Property compound for safe keeping. An inventory was already conducted on June 2, 2010 but Dr. R.F. Sebidos who was present during the inventory refused to sign the inventory report prepared by the Property Office.

We need to do some repairs of the ATEP building and prepare the area for the next harvest. This is only possible if all the equipment, tools/implements are removed from the building. God willing, our production is expected to increase where our existing storage facilities can not accommodate.

I have made arrangement with the Property Office already on this matter. Dr. R.F. Sebidos will be invited and identify the property showing documents that such were purchased/acquired using either SeedNet income or budget allocated to the Department of Plant Breeding and Genetics (DPBG).
