Whereas, pursuant to the Board Resolution No. 14, s. 2006 which granted the University President the authority, among others, the authority to designate deans, campus directors, department chairs and other heads of principal units; and to designate program and project directors/coordinators;

Whereas, pursuant to the aforesaid Board resolution, the University President designated faculty and staff to administrative functions from March to May 2024 per attached list, with relevant documents presented at the meeting of the University Administrative Council on May 23, 2024 and obtained favorable endorsement;

Whereas, finding the UADCO's recommendation in order, the Governing Board has agreed to approve the proposal;


Now, therefore, on motion, duly seconded, and unanimously approved, be it;


