In this connection, all LSU faculty and staff are requested to attend said activity wearing our 2003 Sports Uniform (green jogging pants and jacket).

LSU vehicles will be stationed at Guard Post No. 1 at 3:30 a.m. to conduct all LSU participants to Baybay for those who need a free ride.

- I. The Presiding Officer, Atty. Ernesto M. Butawan, is meantime in court for a hearing, so while waiting, the members of this committee carefully huddled on the collection from last year's Alay Lakad activity which was utilized in a form of Alay Linis.
- II. Mrs. Lolita U. Enriquez manifested that their were 35 barangays who did not give their contribution for the Alay Lakad on some reasons of their own. Hence, as shown in the Financial Statement, the committee got the least net proceeds so far. Mr. Tsaki Mojado, in return, expressed his opinion that since the Alay Lakad is organized as a foundation, "Walk for a cause", to help the out-of-school and those poor but deserving students, so the contributions should be collected. It should not be left as it is, that because they were not able to participate in the raffle draw, and for any other reasons, they would not give their allotted contributions. In fact, he computed the 35 barangays if collected will get an amount of P19, 250.00, and this is already good enough that can shoulder one out-of-school individual who qualifies the criteria to avail the program. So he requested for the presence of Hon. SB Member Michael Cari, the ABC President, so at least an alternative could be done to collect the unremitted amount from the 35 barangays.
- III. At this juncture, Atty. Butawan arrived, and so officially carried on this meeting. Mr. Tsaki Mojado recapitulated briefly on what has been discussed few minutes ago. So promptly, the Chairman remarked that this body should arrive to a right decision now. The Alay Lakad schedule is on Sept. 25, 2005.
- IV. Last year, it was the Mayor's proposal to conduct an operation linis instead of a walk. However, it is a clamor of the majority to impose on a walk, because we can also schedule another day for the Alay Linis, so we can expect more participants. Mr. Tsaki Mojado stressed the importance of a walk because it expresses the real essence of the "Foundation" of Alay Lakad: that we can not just divert such activity for another reality,

though, we can also have the linis if we want to after the walk. He said, we have to understand that the **Alay Lakad Foundation mandates the : "walk for a cause" , so we have to walk. The body agreed, confirmed by the Chairman.**

- V. Furthermore, this body has agreed for an additional physical exercise – after the warm-up walk, then to have a 30 minutes Dance Exercise (or Hataw) to be led by Mr. Eldebrando Buot, together with the teachers from the Baybay National High School. This will be conducted at the Veterans' Plaza, and we may surround the monument.
- VI. The same mode of revenue collection shall be exercised: the circulation of Raffle Tickets to each participating individual in every entity. Each stub costs P50.00 or P5.00 per ticket. To this, the Chairman, Atty. Ernesto M. Butawan, explained that though the nature of giving is voluntary, but since the heads of offices have a moral authority over their subordinates, then it has become compulsory for purposes of helping the noble cause of the Alay Lakad Foundation.
- VII. Assembly Time – 3:30 A.M.
Start of the walk – 4:00 A.M.
Assembly Place – In front of the Roman Catholic Parish Church (if in case it rains, we have the Baybay Gym to shelter us)

- VIII. At this point, arrives Hon. Michael L. Cari. He was informed regarding the problem of unremitted tickets from the barangays. Atty. Butawan inquired when they could have a meeting together with the Barangay Captains, so he could also appear and explain to them the importance of the raffle ticket contributions, so that of the previous year should be collected.

- IX. The Alay Lakad Committee agreed to meet again on September 12, 2005, at 2:00 o'clock P.M., same venue.
- X. The members of this body also touched a discussion about the allowances for the grantees, and some amendments were made, to effect this coming November 5, 2005.
For the High School Grantees – the monthly allowance of P150.00 becomes P300.00;
For the College Grantees - the monthly allowance of P450.00 becomes P600.00.

It was moved by Mr. Ivor Andrew Mojado, duly seconded by Ms. Ivy Ann Mojado, and the rest of the members present. There were no objections nor comments so far, the motion was approved.

- XI. Mrs. Vita Polo made mention about those out-of-school youths who graduated in the Calubian, Leyte government sponsored program. They are now skilled, but could not pursue college education. There are 5 of them who are ready , but who were not able to study even a vocational technical course. She asks this committee what we can do to help.

There was a thorough discussion, then it was clarified that they can just apply for screening and if they qualify our criteria, we can get additional 2 or 3 individuals to study 6 months technical course available here in Baybay, Leyte.

XII. Adjournment:


There being no other matters treated further, the meeting was adjourned by the motion of Mr. Tsaki Mojado, and duly seconded by the rest of the members present.
