R E: Attendance to the EHEM Anti-Corruption Sensitivity Seminar Workshop and Commitment Building Ceremony

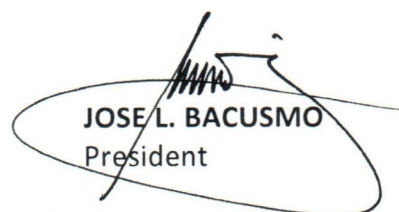
