With the rising positive cases of COVID-19 in Region 8, the City of Baybay reiterated the imposition of Resolution No. 2021-05 issued on May 31, 2021 which says “ **A Resolution Requesting the Heads of all Government Agencies within the Jurisdiction of the City of Baybay to Issue Necessary Memorandum Restraining Non-Essential Outbound Travel of Their Respective Employees/Personnel**” (please see attached copy of the Baybay City Resolution for your guidance).

In relation to this, all VSU employees are restrained from travelling outside the City of Baybay whether its work related or for relaxation activities. For project monitoring, training and other extension activities, please use the existing on-line technologies that are applicable to your situation. However, if travel can't be avoided, then mandatory quarantine should be implemented right after coming back to VSU.

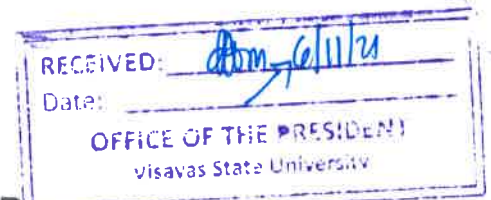

MEMORANDUM

To : All government agencies in Baybay City

From : Office of the City Mayor

Date : 7 June 2021

It has been observed that the number of COVID-19 positive cases in the towns and cities of the Eastern Visayas Region has surged despite the efforts of the national government, and that travelling to areas with known and high incidences of COVID-19 cases is among the major causes of infection and transmittal of the virus.

In accordance with Resolution No. 2021-05 of the City IATF-MEID dated 31 May 2021, **heads of all government agencies within the territorial jurisdiction of Baybay City are requested to issue the necessary memoranda or directives to their employees and personnel to stay in their homes, and that travel outside Baybay City should be limited to essential purposes only.** Non-essential travel should be discouraged in order to reduce the risk of contracting and transmitting the COVID-19 virus.

Minutes of the City Inter-Agency Task Force COVID-19 Meeting, conducted at the IATF Command Center, Diversion Road, held on May 31, 2021.

RESOLUTION NO. 2021 – 05

A RESOLUTION REQUESTING THE HEADS OF ALL GOVERNMENT AGENCIES WITHIN THE JURISDICTION OF THE CITY OF BAYBAY TO ISSUE THE NECESSARY MEMORANDUM RESTRAINING NON-ESSENTIAL OUTBOUND TRAVEL OF THEIR RESPECTIVE EMPLOYEES/PERSONNELS.

WHEREAS, Section 15, Article II of the Philippine Constitution states, "The State shall protect and promote the right to health of the people and instill health consciousness among them."

WHEREAS, the issuance of National IATF-MEID Resolution 101 effectively eased border restriction and quarantine protocols implemented by the Local Government Units (except Baybay City) thereby encouraging non-essential travels to other places particularly those deemed to be tourist destination.

WHEREAS, it has been noted the relaxation of travel restrictions resulted to significant increase in Covid-19 cases in the county, including Eastern Visayas Region;

WHEREAS, the City IATF-MEID, in the regular IATF meeting conducted on May 31, 2021 unanimously agreed to implement strictly travel restrictions in outbound non-essential travels on residents, employees and workers in order to avert the spike of Covid-19 cases in the city.


WHEREFORE on mass motion by all members of the City's Inter-Agency Task Force present, be it;

RESOLVED, as it hereby does RESOLVE, TO REQUEST THE HEAD OF ALL GOVERNMENT AGENCIES WITHIN THE JURISDICTION OF THE CITY OF BAYBAY TO ISSUE THE NECESSARY MEMORANDUM RESTRAINING THEIR EMPLOYEES ON NON-ESSENTIAL OUTBOUND BAYBAY TRAVEL.


RESOLVED FURTHER, to let certified copies of this resolution be furnished to offices/agencies for their information and appropriate action.


