R E: Abolition of the 15 Days Non-Cumulative Sick Leave Privilege to Faculty Members on Teacher's Leave Status

The 15 days non-cumulative sick leave privilege granted to faculty members on teacher's leave status is granted by virtue of Sec. 20, Art. 2, Chapter 19 of the ViSCA Code, which is hereby quoted:

"Sec. 201. Teacher's leave shall consist of thirty (30) days in each academic year, in addition to the usual Christmas vacation. Such leave may be enjoyed only during the regular summer vacation period of the college. However, the President may, at his discretion and on recommendation of the Department Head, grant leave in excess of thirty days to members of the faculty whose services are not required during summer vacation periods.

Each faculty member may be granted an additional fifteen (15) days leave in case of illness during the regular class term, for every academic year, which shall not be cumulative; Provided, that more that five (5) days leave enjoyed due to illness must be supported by a medical certificate.

In case of sickness exceeding fifteen (15) days during a regular class term, teacher's leave with pay not exceeding thirty (30) days in lieu of the summer vacation may be allowed at the discretion of the President; Provided, that the work of the faculty member to whom such leave is granted is duly taken care of without the need of a new appointee; Provided further, that when such vacation leave has been allowed during the regular class period, the teacher's leave for the succeeding summer vacation period shall correspondingly be reduced."

This 15 days leave privilege is in lieu of the recluced summer vacation which is only 30 days instead of the regular 60 days. However, with the grant of the full 60 days summer vacation per Memorandum No. 133, s. of 1991 of this office, this additional leave privilege is no longer applicable, hence, effective immediately, this 15 days non-cumulative sick leave granted to faculty members on teacher's leave status is no longer allowed.

Please be guided accordingly.
