R E: Virtual Orientation on the Comprehensive Land Use Development and Infrastructure Plan Preparation for Visayas State University

In August of 2019, President Duterte signed a law, the Republic Act 11396 or the Land Use Development and Infrastructure Plan (LUDIP) Act. Under Republic Act No.11396, the SUCs governing boards must prepare and implement such development blueprint "to improve and optimally utilize their resources." The law mandates all SUCs to submit their LUDIP to the Commission on Higher Education (CHED) and are directed to follow their respective development plans. The law provides a time frame of two years for SUCs to prepare their respective LUDIP. Land use planning is crucial in directing developments particularly in State Universities and Colleges (SUCs). Recently, investment plans of SUCs have been put on hold due to the absence of their respective LUDIP as mandated on the said Act. As such, there is therefore a need to orient the TWG in order for VSU to craft our own LUDIP based on the law signed by President Duterte.

In view of this, all Technical Working Group of LUDIP are directed to attend this important orientation on March 18, 2021 (8:00 am -12:30pm).
