APPROVING THE CONFERMENT OF TWO THOUSAND FOUR HUNDRED FORTY-FOUR (2,444) CANDIDATES FOR GRADUATION IN VARIOUS DEGREE AND NON-DEGREE PROGRAMS OF VISAYAS STATE UNIVERSITY FOR ACADEMIC YEAR 2023-2024, PROVIDED THESE CANDIDATES HAVE COMPLIED WITH ALL THE ACADEMIC AND NON-ACADEMIC REQUIREMENTS AND SHALL HENCEFORTH BE CONFERRED WITH THEIR RESPECTIVE DEGREES AND CERTIFICATES. BY VIRTUE, HEREOF, THE BOARD VESTS UPON THESE GRADUATES ALL THE RIGHTS AND PRIVILEGES THERETO APPERTAINING


