BOR RESOLUTION NO. <u>97</u> Series of 2024

APPROVING THE REQUEST OF VSU VILLABA TO UTILIZE AN AREA WITHIN THE CAMPUS FOR THE CONSTRUCTION OF TEMPORARY COTTAGES FOR EMPLOYEES

Whereas, the Board of Regents is granted the power to authorize the construction or repair of its buildings, machineries, equipment and other facilities and the purchase and acquisition of real and personal properties, including necessary supplies, materials and equipment. Purchases and other transactions entered into by the University through the Board shall be exempt from all taxes and duties;

Whereas, to address the concerns of faculty members' lack of suitable accommodation options within the locality and provide immediate solution to the issue, the campus officials request permission to use the land for a housing site;

Whereas, VSU Villaba proposed to utilize an available area where temporary cottages for its faculty and staff can be erected;

Whereas, said campus shall cover all expenses associated with the construction, maintenance, and removal of these temporary cottages and adhere to all safety and environmental regulations set forth by the university;

Whereas, Faculty and Staff have committed to contribute financially and through voluntary labor to ensure completion of the housing projects;

Whereas, the University Administrative Council favorably endorsed the proposal in its meeting on May 23, 2024 provided that construction of housing facilities for employees shall be part of the campus LUDIP;

Whereas, finding the UADCO's recommendation in order, the Governing Board has agreed to approve the proposal;

Now, therefore, on motion, duly seconded, and unanimously approved, be it;

Resolved, as it is hereby resolved, that the Board of Regents of Visayas State University approving the request of VSU-Villaba to utilize an area within the campus for the construction of temporary cottages for employees.
