On the scheduled dialogue on Tuesday, 28 September 1999, in VISCA, Baybay, Leyte, Which we agreed to when I was there for the second Public Presentation of the "presidentiables", I was going to meet with the two groups: faculty and students. It seems, however, that there is also need to meet with the alumni.

I would like, therefore, to meet with the faculty from 9:00a.m. - 10:00 a.m.; students from 10:00 a.m. - 11:00 a.m. and the alumni from 11:00 a.m.- 12:00N. I noticed from the schedule that you sent me that you were thinking of a full blown regular program. I suppose you can continue with the other portions in the afternoon. Director Mayo, who is coming with me has to return to Tacloban to catch the 4:00p.m. flight back to Manila. I certainly can stay on for the rest of the afternoon until evening when I plan to go back to Tacloban. I have three Board meetings the following day and I would like to start early since I will be taking the 4:00 p.m. flight back to Manila.

This message modifies my instructions to Dr. Guarte relative to scheduling.

My instructions, however, relative to participants in each meeting of the three groups stand. I request you to please inform the Superintendents of the 4 CSIs, together with their faculty association, student council, and alumni association officers, to attend. This composition pattern also applies to VISCA.

I shall be met at the airport on September 28 by Director Acapulco who will take me directly to VISCA.
